MEMBERSHIP PROGRAMS OFFERED

ASSOCIATE MEMBERSHIP

Your membership grants you access to all Properties Owned by GMHT and Leased by CFFT.

Associate member dues are \$1,600.00 annually. The annual membership dues will be due on January 1st of each year. The annual Membership dues are subject to change. We encourage and look forward to your renewal annually. If you wish to discontinue your Associate membership, please let us know 30 days prior to the expiration date of your annual membership renewal date. Anyone who enters, participates or access GMHT/CFFT facility and overnight stays, is subject to the following camping fees:

- Camper with electrical and water hook up - \$30.00 a night.
- Tent/Dry camping - \$15.00 per night – You would have use of the restrooms and shower facilities. ☐ Please Note: Campers may not be left or stored on the club grounds.
 - o Overnight camping or sleeping in the clubhouse is not permitted.
 - o All Campfires only in designated areas or self-contained firepits approved by the site manager.
 - o We are all volunteers, please leave the club better than you found it.
- Please clean up after yourselves. Please be sure you dispose of your trash in the proper garbage bins.

ANNUAL CAMPING MEMBERSHIP

- This membership is an additional option that can be combined with the associate membership, can't be purchased alone.
- Annual camping membership dues are \$2,400.00 annually.
- Membership dues will be due on January 1st of each year.
- This membership gives you a reserved camping spot for the year.
- You will be able to stay 45 consecutive days at one time. Additional days will have to be approved by the board.
- No Permanent residence is allowed.

GENERAL RULES AND REGULATIONS & BENIFITS

- To provide opportunities for club members to engage in the sport of dog training, testing and competitions.
- To support wildlife conservation programs and to assist wildlife programs.
- To provide a recreational facility for your use and enjoyment.
- To network with other clubs and organizations that share the same objectives as stated in the above items.
- Access to all properties owned by GMHT and/or Leased by CFFT.

- Access to quail, in accordance with all State of Florida Game Preserve laws.
- Access to showers & bathrooms.
- Access to camping.
- Access to fishing. Catch and release only.
- Access to shooting range. Shotgun only.
- Access to boarding kennels for an additional fee.

Your renewal billing will take place on December 1st or each year due on/or before the 1st day of January of the following year. Billing will be provided to you by email, electronic invoice, and electronic payment (Click and Pay).

Payments will be accepted by check payable to CFFT Corporation or by invoice electronic payment only. No Cash please.

Please note: The cleanliness of each member's camper is their sole responsibility. Power spraying exterior is required at least once a year. In addition, there will be no construction of decks or structures on permanent spots without permits.

CFFT/GMHT Board of Directors reserves the right to reject a membership application altogether or to not extend a renewal to an existing member without cause.

Adult Children of Associate Members who are over the age of 25 will be required to obtain their own membership if they wish to visit the grounds on a continual basis. Adult Children of Associate Members will receive a 50% discount on their annual Associate member dues until they reach the age of 28. Individuals aged 28, or greater, will be required to apply for an Associate membership of their own at the current annual rate.

USE OF GROUNDS AND GENERAL USAGE:

1. Grounds are for training of personal animals, trialing, and related activities.
2. Good sportsmanship is to be exercised by members sharing training fields. There is a 30minute limit if someone is waiting to use a field. You would be required to put the red flag up on the mailbox of the field you will be occupying to indicate the field is in use.
3. Motorcycling and other activities deemed inappropriate by the Board of Directors are not permitted. Vehicles other than ATV's, side-by-side or golf carts are not permitted on the fields.
 - a. Please do not exceed 20 mph on any vehicle on the roads or grounds. Children are not permitted to drive unless they have a license, or unless they are UNDER DIRECT SUPERVISION of their legal guardian and in compliance with Florida State Laws.
 - b. Use of the clubhouse is not permitted except for bath and shower facilities and use of the ice machine.
 - c. Associate members are permitted to bring a member of their immediate family or significant other as a guest.
 - d. Animals are not permitted in the clubhouse or camping area overnight unless they are being kept in a trailer. For your safety, and to avoid electrical shock and possible damage to the water lines, please do not stake your dog out in the camping area. You

may request permission for stake out area from one of the Board of Directors or the Property Manager. They will be able to direct you to a safe area.

- e. Anyone observed misusing a firearm or bow will be brought before the Board of Directors for appropriate action.
- 4. You are permitted to use the shooting range only if there is not an active trial event on the fields. Please pick up your papers and shells and leave the area clean for the next person. Shotguns only; NO rifles allowed.
- 5. Alcohol is not permitted in any of the fields or while any event is being conducted. Our sportsman's insurance does not allow it.
- 6. We are a family-oriented club; sportsmanship will be expected from everyone. Yelling, screaming, or cussing will not be permitted.
- 7. We do not have maid service, so if you use the showers or restrooms, please be sure they are stocked with toilet paper and hand towels. Supplies are in the storage closet in the clubhouse.
- 8. If you notice that something is broken, leaking or noticeably wrong, please let the grounds manager know, or contact a Board member... or repair it.

CAMPING:

Camping on the grounds is permitted with notice. Our Site Manager, Mike Wayne, will record camping stays and we will

send an electronic invoice for charges.

Anyone who enters, participates in or access GMHT/CFFT facility and overnight stays, is subject to the camping fee's stated above.

WILDLIFE:

- No hunting of deer or wild turkey is permitted on club ground by anyone.
- Fish are catch and release only.
- We have Indigo snakes; it is illegal to kill them.
- We also have Gopher turtles; it is illegal to disturb their den or to kill them.
- Violation of these rules is a serious infraction and may result in immediate suspension from the club, with no refund.
- Members, Guests, and children; **NO** swimming in the lakes or ponds. Please be aware of rattlesnakes, water moccasins and/or alligators.

BIRD USE:

- October 1, 2023, Member Bird Cost: \$6.50 *Prices are subject to change based on Market Pricing, Seasonal Rates and availability.
- CFFT will, in accordance with all State of Florida Laws and Regulations, attempt to provide its members with year-round access to quail or appropriate game birds for your

usage.

- CFFT will attempt to contract the appropriate game birds for your usage within our facility and to the extent of CFFT's permits and licenses. In some circumstances, game birds may not be available to the members, this may occur due to supply availability.

The only birds permitted at our facility are the ones we provide. Bringing birds from other providers is not permitted. We are a Game Preserve Violation of this rule is a serious infraction and immediate suspension may follow. IN ACCORDANCE WITH OUR GAME PRESERVE LICENSE ISSUED BY FWC, ALL BIRDS MUST BE USED ON THE PRESERVE, KILLED ON THE PRESERVE AND DISPOSED OF ON THE PRESERVE. NO LIVE BIRDS, CARCASSES OR PARTS CAN BE TAKEN OF THE PREMISES.

You will be required to sign for all birds that you remove from the bird pen at the time they are removed. Once they are removed from the pen they cannot be returned. It is a violation of the club rules to remove birds from bird pens without writing down the birds used in the log provided. If in violation you will be subject to disciplinary action up to and including suspension from the club with no refund.

Your bird usage will be billed to you at least monthly. Past due bird bills will be assessed an 8% late fee. If a bird bill goes 30 days past due, future use of birds will be suspended until the bill is paid current.

All dead birds should be removed from the fields. They need to be put in a dumpster designated for bird disposal. No dead birds are to be left in the trash cans, this will invite rodents, snakes, coyotes and other animals.

If you use the catch bins in the quail pen, please do not leave any birds in them and close the catch doors. Birds left in the catch bins and birds getting into the catch bins after the fact will die.

VIOLATIONS AND DISCIPLINARY ACTIONS:

Any member who knowingly commits an intentional act to disturb the harmony of the club will be brought before the Board of Directors who will determine the plan of disciplinary action which could include permanent suspension from the club, or other action, depending on the severity of the violation.

The GMHT/CFFT Board of Directors shall hold all authority of the club.

Compliance with the above rules is mandatory. Violators can be asked to leave at any time. Your Associate membership can be suspended at any time for any reason the board deems feasible. If you are suspended, you will forfeit any dues paid for the remainder of the year.
